Trade - A Driving force for Jobs & Women's Empowerment?

Trade liberalisation is widely seen as a driving force behind economic growth and poverty reduction. Proponents of neoliberal economics such as the World Bank2 and economist Jagdish Bhagwati3 suggest that trade liberalisation is a driving force for gender equality as well. They regard free markets as the best mechanisms for resource allocation, wealth creation and distribution, and the narrowing of gender gaps. This is based on the assumption that trade produces growth, and that growth will open up opportunities for better education, more jobs, higher income, more credit and better opportunities for women entrepreneurs.
